Who needs Fiscal Representation in Portugal?

Non-resident taxpayers who earn taxable income in Portugal & the Algarve are required to appoint a fiscal representative who guarantee's that the non-resident is compliant with Portugal's tax obligations. Brexit without an agreement will also require mandatory a fiscal representation as from 01-01-2021.
